

Time Estimate

Pursuant to the Superintendent’s Second Procedural Order, Anthem Health Plans of Maine, Inc. d/b/a Anthem Blue Cross and Blue Shield (“Anthem BCBS”) estimates that presentation of its direct case on the hospital savings initiatives will take approximately one hour and presentation on the remaining topics will take approximately 15-30 minutes per topic. Until such time as Anthem BCBS has an opportunity to review prefiled testimony from other parties, it is difficult to estimate the time that will be necessary for non-duplicative cross-examination. With that said, Anthem BCBS’s current best estimate of the time required for cross-examination is 30-45 minutes on the hospital savings initiatives and 15-30 minutes per topic on the remaining topics.
